TENANT INFORMATION



Please remember that your full rent is due on the 1st of every month, no exceptions. To ensure rent payment is on time, set up your pre-authorized payments or pay by post dated cheques. Ask you property manager for forms. If you do not pay your rent on time, you may receive a 10-day notice.

No rent increases until August 2021

BC RECOVERY BENEFIT

The BC Recovery benefit is a one-time direct deposit payment for eligible families, single parent families or individuals.

\$1000 for families and single parents with incomes under \$125,000. Families earning up to \$175,000 will qualify for a reduced benefit amount. Single parent families also qualify for these benefit amounts.

\$500 for eligible individual earning up to \$62,500. Individuals earning up to \$87,500 will qualify for a reduced benefit amount.

Tenant winter checks:

To avoid condensation,

- Clean bathroom exhaust fan grills
- Leave your door open when showering
- Make sure air can circulate behind furniture
- Open windows. A well-aerated home is less humid and easier to heat

Winter cleaning and maintenance,

Remove dust and dirt behind stove and refrigerator



• If you are in a home with outdoor water access, to avoid a frozen tap, make sure the water supply is turned off.

Over the next few months your Property Manager will be scheduling gutter cleaning and furnace servicing.



CASA Holiday Hot Cocoa

1/4 cup unsweetened cocoa

1/2 cup granulated sugar

1/8 tsp salt

1/3 cup hot water

4 cups milk dairy or non-dairy

1 tsp vanilla extract

- 1. In a medium saucepan, combine the cocoa powder, sugar and water and salt.
- 2. Cook stirring constantly until smooth and bring to a simmer.
- 3. Reduce heat and stir in the milk. Do not boil.
- 4. Remove from heat and stir in the vanilla. Pour into mug and add a candy cane, marshmallows or your favourite liqueur.

This change is retroactive to all tenancies entered in to before the "Cannabis Control Date" which was the date this legislation became law.

The cultivation of cannabis in rental units has a retroactive prohibition on the growing, cultivation, and harvest of cannabis in all rental units across BC. Many strata's have the same restrictions. NO growing or cultivation is allowed.

NO SMOKING OR VAPING the use of tobacco, cannabis, vape devices is strictly prohibited in or outside any CASA rental property
